22 of Live Birth, consents to the Petition herein.
- 23 4. Petitioner, **MOM/DAD**, requests that the court appoint **GUARD1** and **GUARD2**, the
24 minor's RLT2MNR, as legal guardians of the minor, **MINOR**, to assume the care and responsibility of
25 HER/ HIM and provide for HER/HIS everyday necessities of life.
